We work to make sure people:


- get their human rights

The Commission started in 2007 when we took over from the Commission for Racial Equality, the Disability Rights Commission and the Equal Opportunities Commission.



We make sure people follow the laws on treating people equally and fairly.



We find out what is happening across the country and we tell government and everyone else about how important this all is.



We also write guides to help organisations and businesses work in better ways.



We help everyone understand more about why people are being treated unfairly and what can be done to make things better.



We also work closely with the Scottish Commission for Human Rights.

• put the most important points for the plans up on the same website




• ask you if you think these points are the right ones.

2. How can the Commission share information in better ways?




Our business plans

Having a good business plan is very important. It brings all the different parts of our work together so we know what we are doing.



Having a business plan that you have helped us make means we know what people want us to do and the things we all want to change.



The business plan will be for 3 years from April 2009 to March 2012 and will take over from the one year plan we started with.



The Commission's 1st business plan

To get us going, we had a business plan that covered our 1st year (2008/9). We also involved people in writing that one.



It included these points:

1. Main areas

working to make things more equal



 helping communities and people live together better



• thinking about the things that are important to us all.




2. The most important points

 find out and do something about the most important equality and human rights issues



• make public services better



 include and help people from communities and areas that are run down or less well off



• think about what is changing and what we can do to help make things fairer and more equal for people.



3. Work that has gone well

 we started looking at how human rights were working in Britain



 we launched 'Working Better' to get people working in fairer ways



• we supported a court case to help carers.



4. Other work we are doing

making sure people follow the law



 getting people to support a new single law on equality



 working on what we do about Human Rights



 writing a 3 year report of how equal things are in Britain.

Our 3 year business plan

We think that lots of the ideas in our 1st year business plan should go into our 3 year plan.



We will also need to think about how the country is changing, things like the 'credit crunch', as well as the things we want to do in a planned way.



We have started thinking about what are the most important things to do in the next 3 years and want your help with the plans, so we have come up with these questions.

Questions to think about:




1. The commission is here for everyone in Britain, but where should we spend most time and money so that the most people are helped?




- **2**. At the moment there are 7 main areas in the law that we think about, these are:
- disability




gender

Grants

We give money to organisations that help us make things fairer and more equal (these are called grants).



At the moment we give nearly £11 million to 285 organisations, mainly for short project work.



We need to make sure we make the best use of this money and organisations are doing the things we want them to do.





We think we should give money in 2 ways, for shorter work on special projects as we do now, and for longer work, up to 3 years, for organisations who are doing the things we have in our business plans.

2. How can we check these organisations do the work in the right way?


